


"Big Four" Accomplishments





Storm Sewer Maintenance - Work now underway on more than \$60 million in identified storm water system improvements to reduce or prevent local flooding, basement backups, etc.




Water System Improvement Program

(Accomplished) — Largest investment in our water system since we built Lake Decatur in early 1920's. In some instances it FIXES the water supply problems that we've had for years.






"Big Four" Accomplishments



Police Department Relocation – Officers officially began operating out a new state-of-the art facility in 2014 after years of work to find a new location for the Department.



Maintenance for Sanitary Sewers (Ongoing) -

Able to negotiate Administrative Court Order between the City and the U.S. EPA. Expected to be less intense and less costly.

- 44 Public Suggestions incorporated into groupings






ECONOMIC DEVELOPMENT



Approve local motor fuel tax - Passed February 2016. April collection of \$121,725/2016 projection of \$1.4 million.



Repave/rehab local streets- Local MFT funds to be designated for local streets. Work to begin this summer.



Repair/Rehab fire stations - Dewberry study complete. Funding built into 2016 Tax Levy



Support major road projects - Established multi-government transportation team & hired Anne Schneider in WHEN. WHAT IN Grant applications submitted



Implement Sewer Improvements - Stormwater Utility passed in when. Part of \$60 million in work now underway. US EPA Consent Degree being reviewed.


2015 MISC. SANITARY/STORM SEWER WORK



Area 2 - ECONOMIC DEVELOPMENT – CONTINUED CREATION OF A COMMUNITY OF CHOICE FOR DEVELOPMENT

- Establish pro-growth policies for development
- Extend hours of service for select bus routes
- Connect Decatur to Amtrak by bus or interurban line
- Put key performance indicators in comprehensive plan
- Expedite city permitting processes and other ways to facilitate doing business in Decatur

- Make Decatur most competitive business climate regionally (written economic development plan) (4)
- Provide a strong economy with good jobs (skills training for better jobs)
 (2)
- Establish a new or improved corridor for retail sales (e.g., Mound Rd. and Route 5 I intersection)






Area 3 - Neighborhood Revitalization

- Provide housing stock revitalization program enhancements (with partners) (3)
- Stabilize/improve local equalized assessed valuation (EAV) (2)
- Secure the Millikin to downtown walking/biking corridor (2)
- Clear properties of problems that negatively impact EAV

- Enhance code enforcement for improvement of housing
- Increase number of community cleanup projects annually
- Remove impediments for a successful side yard program






Area 5 - Organizational Operations

- Develop new sources of revenue not burdensome to taxpayers (reasonable) (2)
- Make goal setting (strategic planning) an annual precursor to budget discussions (2)
- Seek local government consolidation and cooperation (2)
- Establish a residency requirement for all new hires(2)

- Conduct a health fair for employees
- Build up cash reserves
- Put billing period on utility bills
- Carefully review future water rate increases






Area 5 - Organizational Operations

- Hold an emergency
 management conference for
 Council and staff
- Move Plan Commission meetings to an evening time slot


- Lobby to curtail tax cap legislation for Macon County

- Engineer savings into City systems


